## **Request for Bids Small Works (Two-Envelope Bidding Process)**

1. The Borrower, Bosnia and Herzegovina has received financing from the International Bank for Reconstruction and Development toward the cost of the Sava and Drina Rivers Corridors Integrated Development Program Using the Multiphase Programmatic Approach (SDIP). For the purpose of financing of the SDIP, part of Phase 1 of the Program, part of the loan in amount of EUR 25 million has been granted to the Brčko District to finance improvement of flood protection and environmental management within nominated projects part refers to Brčko District of B&H and intends to apply part of the proceeds toward payments under the contract for Works for Regulation of the Blizna Stream in the Urban Area of the Brčko District – Bosnia and Herzegovina.
2. The Development – Guarantee Fund of Brčko District on behalf of the Government of Brčko District now invites sealed Bids from eligible Bidders for the construction and related works for Regulation of the Blizna Stream in the Urban Area of the Brčko District – Bosnia and Herzegovina in compliance with the national legislation and the Detailed Design prepared by the Employer and reviewed and approved by the relevant technical committee.
3. Blizna creek is right tributary of the Sava River, which flows into it 3,180 meters downstream from the mouth of the Brka River. This watercourse is completely unregulated. In the confluence area, on the left riverbank, city landfill is located and above it, the plant of the former rendering plant. On its right bank, the construction of a central wastewater treatment plant is planned. The Spatial Plan of the Brčko District of Bosnia and Herzegovina foresees a protective zone for the Blizna creek and its tributary, Grčica creek. Within this protective zone hydro-technical works on the regulation of the river bed shall be executed. Detail design for regulation works is prepared and approved

by relevant authorities and in compliance with it, regulation works, shall include following main type of works:

- Construction of embankment up to the levels specified in the Detailed Design;
- Riverbed regulation by concrete linings of revetments and river bed;
- Concrete works for inflow facility at the junction of Grčica creek into Blizna creek (casing of Grčica creek);
- Execution of drainage channels and riverbank revetments;
- Construction of stairs for going down to the bottom of the riverbed and hinterland waters facilities;
- Land shaping and grass planting;
- Backfilling of old riverbed of Blizna Creek upon completion of regulation works.

Contract duration is 10 months. Defect Liability Period is 12 months.

4. Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers (July 2016, revised November 2017 and November 2020) ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
5. Bids will be evaluated in accordance with the evaluation process set out in the bidding documents. The following weightings shall apply for Rated Criteria (including technical and non-price factors): 30% and for Bid cost: 70%.

All envelopes marked “FINANCIAL PART” shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
11. All Bids must be accompanied by a Bid-Securing Declaration in the form and in compliance with the conditions indicated in the Bidding Documents.
